TUITION/LATE FEES

Tuition is due on the first lesson of each month. If tuition is not received by the 10th of each month, a \$10.00 late fee will be billed to your account the following month. In this manner I will be able to keep tuition at a minimum cost. You may bring your tuition or mail it to the above *Mailing Address*

CLASS CANCELLATION/TERMINATION OF ENROLLMENT

Students who are interested in enrolling in the Spotlight or Playhouse Vocal classes may attend the first class for a free observation/participation. If at the end of visiting the class they decide to enroll, then the tuition for the remainder of the month is due upon enrollment. If the student decides not to enroll, then the observation class is still free of charge and they will not be committed to a place in the class. A 1 month notice is required for cancellation or “dropping” the class or lessons (basically giving up your spot in the class without notice) or you will be billed for one month of services after you cancel.

PRIVATE VOCAL STUDENTS: Private vocal students will be billed a month in advance based upon their lesson schedule upon enrollment. If you begin in the middle of the month, your first month’s tuition will be pro-rated. A courtesy of 1 month notice is required for cancellation of your students’ lesson time. If a 1 month notice is not given, you will be responsible for payment for 1 month of service from the time your student “drops”, cancels or terminates his/her lesson time.

SHOWCASE & PERFORMANCE OPPORTUNITIES

A bi-annual performance opportunity will be offered for students who study both privately and in the classes. Performances are in December and June of each year and are optional to all students. Occasionally we will also offer performance opportunities throughout the year in addition to December and June. Once a commitment is made by the student and/or his guardian to be in the performance his enrollment into the showcase is taken very seriously. Should the student cancel, or drop out of the showcase after making this commitment, he will not be allowed to return to Sacramento Performing Arts Co. to study for the period of 6 months.

There will be a \$125.00 Showcase fee for students who wish to participate in our annual student vocal showcase held at Cosumnes River College. If we have performances in venues that have lower rental fees and costs then the showcase fee is adjusted to reflect that savings on to you, the student. This fee includes a PROFESSIONALLY RECORDED DVD OF THE SHOWCASE. This fee will be charged to your account the month of the showcase. Students may be responsible for their own costumes or will be able to rent costumes from Kim for a minimal cost for specialty or solo numbers. All group number costumes are provided by Kim and charged a rental fee of \$10.00 per costume. Tickets to the concerts are \$12.00 and are sold separately. Concert fees and tickets are solely for the purpose of paying for theater rental, lighting, sound etc. If students participate in a concert, then parents must volunteer to help with some aspect of running the show. Parents may also volunteer sewing, painting or using other talents instead of working a show, loading in or striking a show (ie tearing down afterwards).

COSTUMES

Students will be billed \$10.00 per costume that is rented from Kim Cyrus and may be responsible for some of their own costume pieces. Students are not required to participate in vocal showcases, but will be highly encouraged to do so to benefit the purpose them taking vocal lessons, gaining more confidence and becoming much more poised and trained for auditions and other performance opportunities that will surely come their way!

LEARNING/BEHAVIOR DISCLAIMER

As the instructor and director of this program, I reserve the right to offer the student other options for music study as I see them necessary after working with the student for a period of time. If I feel that the student would better benefit from more one on one structure rather than in a class setting, I may offer that as an option for the student to be able to receive the full benefit of musical training in this facility. If at anytime, I feel that I am unable to serve a student in a manner that would best suite their learning style; I will consult the Parent/Grandparent or guardian and the student at that time for other options.

I the undersigned parent/student understand that as a voice student of Kim Cyrus at the Sacramento Performing Arts Co, I am expected to pay tuition fees at the 1st lesson of the month and no later than the 10th of the month. **I understand that missed lessons will not be credited or refunded should I/my student miss a lesson or class. If Kim has another lesson time available for me a make up lesson may be offered. If Kim misses a lesson a credit will always be given for that lesson.**
